6. Treasurer's report

Deposits for the month totaled \$8,905.13, which included our shared revenue payment and a driveway permit. Our operating balance for the remainder of the year is \$98,270.93

We paid several significant bills this month, including the annual insurance premiums for 2022, which totaled 10,937. We paid modern heating and cooling for their installation of the new garage water heater, \$353.43. We also paid the 4th quarter levy for District 1 EMS, \$1213.89 and we paid our annual contract and licensing fees for our voting machines, \$412.

We will be getting about \$700 back from the State Unemployment Agency that we had to pay out early in the Covid Pandemic. We are also working on getting some money back from Hallada for repairs that they did for some Ford recalls that are retroactive.

We had one new single family building permit this month, for 3976 Hwy JJ

Karen made a motion to approve the clerks report. Motion carried 5-0

8. Payment of bills

Doug moved to pay the bills. Motion carried 5-0

9. Patrolman Report, Mt. Horeb Fire Department, Black Earth Fire District and District 1 EMS Reports

We just put new batteries in the IH truck as the old ones were 9 years old. Jack has been putting up replacement road signage.

Mount Horeb Fire has a new bill collection agency they are working with as backup.

Black Earth Fire has been having discussions about balancing expenses year to year.

District 1 has \$101,612 in its ambulance fund and 35 volunteers. The postcard campaign brought in 8 people, 6 of whom were interested and two that signed up. They also have a new automatic CPR machine. The first payment for it will be covered by the fundraising.
